#### Lawrence Township:

- Handouts of Senior Services Events currently scheduled
- The Senior Services millage passed resulting in the Township now receiving a half Mill vs the previous quarter mill. Serving on average 100 lunches.
- The Township road millage was approved for 2 mills

- Results of Broadband survey conducted by the County. Lawrence is underserved by 59%, if you remove the Village the Township is underserved by 61%. 2.4 4.2 million needed to bring all of Lawrence Township up to service levels. 40 million to cover the entire county.
- Watervliet dump gives dump passes twice a year. Other Townships are issuing passes to residents allowing them to take one (1) truck load to the dump during a weekend in April and September and the Township pays the invoice. Lawrence Township will be looking to do something similar in the Spring.
- Red Arrow Highway will be repaved from the Village Limit West to CR 681 in October.

# Lawrence Township Emergency Services:

- Ox Roast Traffic coming East prior to truck parade should be routed down Michigan earlier to avoid endangering the folks setting up in preparation of viewing the parade.
- The will be making sure that the trucks are traveling single file vs side by side because they were getting close to spectators while traveling down Red Arrow.
- Working on recruitment
- Fall Fire Prevention is starting. There have been 80 fire deaths of adults to date. Free smoke alarms are being given out.
- The pancake breakfast brought in about \$1600.
- Working on writing policies for the Fire Department

 Dumpster Program – Local business owner was concerned about trash being left outside the dumpster, unauthorized persons using the dumpsters, the locks being unreliable. President Quick investigated and found that the Village pays \$900/mo subsidizing about \$500+/mo. President Quick feels that the Village should remove itself from the situation and allow the business owners to secure their own trash removal. If approved businesses will be given 45 days notice that the dumpsters are being removed.
