Quick- Available grant with 90/10 match with 2-million-dollar cap. Previous started by Dan Faulkner (Ice Grant).

Dan Dombos-will include 3 waste systems and aging infrastructure. Original estimate was \$900,000.00 (1 million with upgrades).

Quick-How likely are we to get approved?

• Joelle-we are on the eligibility list for infrastructure and Waste.

Webster-If work has been done prior under the ice grant was the engineering cost paid? Dan Dombos-It was only the preliminary maps (no construction plans; more conceptional).

Webster-What is the timeline on the grant application? Joelle-Due by May 31st.

Ouzts-likelihood % wise of getting approved? Joelle-Depends on prep and supporting documents. There is a limited pool of 20 municipalities.

Webster-Will Engineering be covered under the grant?

Quick-Yes; Abon Marche has agreed to prep and submit the grant at no cost unless the grant is approved.

Request by Paul Bianco-Police Vehicle

Has been researching cost of used vehicles with not much luck. Has been in talks with Craig McDonald with McDonald towing. He purchased 20 vehicles from Ziegler in Plainwell and has 3 left. All are black in color.

2021 Explorer base price would be \$38,272.00. He would have additional expense3s to add equipment and full quote would be around \$49,676.00. Quote is below the State Quote.

The current vehicle has 97,000.00 miles on it. New vehicle would come with 100,000. Mile warranty.

- Webster-These are unbudgeted funds. Where is the money coming from?
 - o Bianco-\$25,000.00 was put into equipment fund from the Marijuana money. \$20,000.00 is still not allocated. May need additional funding as a back-up.
- Ouzts-Is milage still an option?
 - o Stroud-Yes; will discuss at next meeting.
- Quick-Timeframe?
 - o Bianco-He has possession of the car; would need to order parts. Issue is we are at the mercy of the State on radios.
- DeLoach-If we have 2 cars can we get more presence on James Street?
 - o Bianco-yes
- Stroud-Consumers will be parking at the corner of James and Michigan Street.
 Working on a new substation. Will be out by Mid-September. Do they need permission from the Village?
 - Quick-as long as they are not on our Right of Way; no.
- DeLoach-Can the grant include 3 lift stations, school, Blackman, Sewer Jetter?
 - o Johnson-will be discussing with Dan what will be included in project.
