#### **Clerk-Presented by Everhart**

- ii. Do we want to charge penalties on golf carts if they do not register for permit?
  - a. Stroud-we currently have language in the Ordinance that states there is a penalty but there is nothing in the fee schedule or language to indicate what the penalty would be.
  - b. Ouzts-Ordinance follows state law.
  - c. Quick-do we want to make it a tier penalty? \$25.00, \$50.00 and \$100.00 by violation.
  - d. Glennie-what type of ticket would be issued?
    - i. Bianco-would be based on the Ordinance but could do fine which would fall under the Village.
  - e. Quick-likes the idea of doing a fine versus a citation.
  - f. DeLoach-Do residents need to show proof of insurance?
    - i. Group consensus is not sure.
  - g. Ouzts-We need to get with attorney to go over language in the Ordinance.
    - i. Stroud-could also include removal of Sunset Clause in current Ordinance.
  - h. Glennie-would this be the same as Blight?
    - i. Bainco-No blight citations go through the County and can go to court.
  - i. All agree to have attorney review Ordinance and do as a fine and write as a policy so changes can be made without redoing the Ordinance.
- iii. Postage machine-having continued issues with the Lawrence USPS. Looked into getting an upgrade on current postage meter. Was provided 2 options but lowest options would be an additional \$50.00 month from current meter. We do not feel the additional cost is effective. Called Paw Paw USPS to see if account could be moved to their facility. Spoke with Sharon; she is researching this option but would require us to get a new permit number. We have Utility Bill stock in house for an additional couple of months with the current permit number so have time to research before making a decision.

  - a. Quick-How often do we replace?
    - i. DeLoach-every 2 to 3 years in the past. Doesn't feel it is necessary annually.
- ii. Would like to work with Shawn Baker at ISD to see if we can combine delivery on future orders to cut cost.
- iii. Met with Amos Alexander with True Leaf. Toured all possible locations. Amos recommended the North River location as it is visible to the public. Amos is an active Kayaker and showed interest in sponsoring.
