Hi Alicia and John,

Based on my quick research, it appears that the Village of Lawrence is not a non-profit and does not have a 501(c)(3) number. If this is correct, the Benevity platform will most likely not approve the addition of the organization to the approved matching organization option.

That said, if you have not already done so, have you considered creating a non-profit specific to the fundraising initiative for the park grant? I am not sure if this is even a possibility, but it would allow me and any other Pfizer employee to get matches for 1:1 donations and then 2:1 donations to the effort twice a year (once in June and once on Giving Tuesday in Dec), not to mention the tax deductions for other donors. If you decide to look into this, I can help dig into what would be involved to establish a 501(c)(3) for the new playground grant sponsorship program.
