Presentation: Police Services for Township.

See slide show presentation. Proposal to contract services with Township for 20 hours a week coverage.

- Comment: Ouzts-How does the coverage plan look?
 - Bianco-can be adjusted as needed.
- Comment: Ouzts-How many calls after 11:00 PM?
 - Bianco-unable to provide; stats do not include that information. There is generally a large drop in calls after 11:00 PM.
- Comment: Ouzts-Are we not doing a joint mileage with Township?
 - Quick-The township has decided not to do joint mileage with the Village.
- Comment: Ouzts-If Twp. contracts with the county would it be a yearly contract?
 - Bianco-Yes; if the Township decides to contract with the Village, he is going to request a yearly contract as well.
- Comment: Gritter-Can we bill for medical calls?
 - Bianco-Yes; we would bill them at an hourly rate.
- Comment: DeLoach-If they don't join; do we still need 4 officers?
 - Bianco-Yes; they are only part time.
- Comment: Webster-If we go with a split mileage, we will split time?
 - Quick-No; we will do mileage on Village only.

No further discussion.

Refinances of Infrastructure Loan.

- 1 Million loan with pay off in 2042
- Current interest rate of 4.2 %
- New rate will be between 2.5 and 3.00 %.
- Remaining balance is: \$732,000.00

Stroud-requesting permission to research refinancing options of the loan at lower time span and rate.

- Stroud- Has everyone had an opportunity to review?
 - Comments: everyone is okay.

Annual Right of Way Permits.

- Consumers feels we are under charging for permits.
 - Stroud-per Consumers we could be charging as much as \$500.00.

Special Office 365 Groups.

- Stroud- With the new Office 365 set up at the Village; all groups were removed. She was attempting to create the groups again; thus, email notifications to each member of the group(s).

Treasury Position.

- Stroud- should we change the job title to get more applicants?
 - Comment: Webster-How about changing to Account Clerk? Are we posting locally?
 - Stroud-will change job title. Yes, only posting through free advertising at this time.

LDFA/DDA

- Quick-meeting held with LDFA/DDA lead to research of tax capture and monies owed to the Village for payments toward the water tower loan.
 - Comment: Webster-heard discussion in a meeting that them want to dissolve the LDFA.
 - Stroud-they cannot dissolve until they have no debit.
 - Quick-LDFA is not getting a lot of tax capture. LDFA had requested the Village to review and pay the LDFA.
- Quick-Stroud spent 10 hours researching LDFA financials for the Township. An invoice has been created for \$275.10. Quick would like Council to approve the ability of the Manager and or Clerk to create invoices for time spent at their discretion (over an hour suggested).
- The Village attorney was also used to research LDFA/DDA finances. The total amount of cost is \$1237.00.
- Both invoices will be presented to LDFA/DDA in meeting on 3/24/21.
- Quick-Will also be requesting a written contract for payment arrangements toward the water tower loan.

- Quick-Awaiting updates from Governor on holding live meetings. Until otherwise we will move to Council/Committee live meetings with all public held via Zoom.
- DeLoach-When are we going to have someone clean up the lot from the water leak last year.
 - Stroud-Now the weather is breaking we will have our DPW staff start clean-up.
- Stroud-Starting work on Blight notifications. Currently has 14 residents on the list.
