- Continue to keep an eye on blight issues/long grass.
- Still working on obtaining 2-shotguns for patrol vehicles, limited options at this time.
- Received field drug test kit to assist with suspected substances.
- Continued to work with Kelly in reference to updating the parking ordinance.
- Exploring different options to purchase 1 to 2 heart starts for patrol vehicles.
- Jeff Mack has worked a couple of weekend shifts. Still trying to find another part time officer.
